



2025 Qualified Interest Income (QII) and Qualified Short-Term Capital Gain Percentages for the BondBloxx ETFs

Certain BondBloxx ETFs generate qualified interest income and short-term capital gains that may be exempt from United States withholding tax when distributed to non-U.S. holders. The U.S. tax law permits a regulated investment company (RIC) to designate the portion of distributions paid that represent interest-related dividends (commonly referred to as qualified interest income) and short-term gain dividends as exempt from U.S. withholding tax when paid to non-U.S. shareholders with proper documentation.

The distributions that have been identified by the BondBloxx ETFs as exempt from U.S. withholding tax are disclosed in the table below. The information is subject to change. We recommend that you consult with a professional tax advisor for more information.
